

Member and Partner Categories and Annual Dues Schedules

Every IOGA Member and Partner is listed under one of the following categories:

- **Producer/Operator** – Those who prospect, develop and produce oil and natural gas. Includes those who have management responsibilities as either companies or general partners; those who are in charge of the operation; or those who are in the business of producing and operating wells.

Dues: \$ **500.00** per operated WV Horizontal, Marcellus or deeper Well (any horizontal well below the top of the Tully)

 \$ **35.00** per operated WV Vertical Well

 \$ **15.00** per operated WV Well producing 5mcf or less, or contract operated with no working interest

Minimum = \$ 500.00 Maximum = \$ 25,000.00 if you only have Vertical Wells. **\$ 30,000.00** if you have 10 or more Horizontal, Marcellus or Deeper Wells

- **Gas/Oil Marketer** – Those whose primary business is to serve the industry by assisting and participating in the marketing and/or selling of gas and/or oil.

Dues: \$ **2,500.00**

- **Allied** – Those whose businesses are directly related to the oil and gas producing industry such as, but not limited to, service and supply companies, truckers, sales representatives, banks, etc. Dues are based on the number of WV employees directly related to the oil & gas industry.

Dues: \$ **500.00** less than 25 such employees

 \$ **1,000.00** 25-50 such employees

 \$ **2,000.00** 51 or more such employees

- **Professional** – Those who serve the industry in a professional capacity such as attorneys, landmen, accountants, surveyors, consulting geologists, engineers, geophysicists and financial advisors. Dues are based on the number of WV employees directly related to the oil & gas industry.

Dues: \$ **500.00** less than 25 such employees

 \$ **1,000.00** 25-50 such employees

 \$ **2,000.00** 51 or more such employees

- **Associate** – Those with an interest in the oil and gas industry and do not qualify under any of the other membership categories.

Dues: \$ **250.00**

- **Royalty Owner** – Those whose **only interest** in oil and gas production is through the ownership of the royalty, and do not qualify in any of the other membership categories.

Dues: \$ **150.00**

A member or partner qualified during a membership year under more than one category shall only pay dues under one category, which, except upon approval of the Board, shall be the category providing for the highest level of dues for that year.
